

Staff absences – sickness, shielding WISH estimates 15 – 50%


Social distancing

In Tameside, Greater Manchester, grounds maintenance staff are now working in waste and recycling, while library staff are working in the contact centre to deal with the increase in calls.














Service Delivery - Collections













Defra Guidance – Service priorities

- Dry recyclables (Weekly)

- Replacement containers




COVID-19 WASTE UPDATE

If you can help, please wipe down the handles and lids of your bins when you put them out and again when you bring them in. Let's do what we can to stop the virus spreading.









If you have symptoms of Coronavirus or confirmed to have Coronavirus, all personal waste (such as used tissues) and disposable cleaning cloths:

- Must be placed in a plastic rubbish bag and tied when full.
- The plastic bag should then be placed in a second bin bag and tied.
- Store securely and keep separate from other waste for 72 hours. Waste should not be stored in communal waste areas.
- After 72 hours place the bag in your usual external general waste bin.

Please clean the handles and lid of your bin before and after you put it out to keep our operatives safe and stop the spread of COVID-19. Make sure you wash your hands after retrieving your bin.

Coronavirus pandemie

Mike Smith, from Hebburn, has made a claim for the money he paid for the service because he could to get an answer about when it would resume.

South Tyneside Council said it halted the collections to concentrate on critical frontline services.

• Deputy leader of Hampshire County Council Rob Humby said: "Last weekend over 29,000 people visited Hampshire HWRCs - to put that into context, our busiest Easter bank holiday weekends might see a maximum of 22,000 people"

Dumping outside charity shops


Leeds (and others) not emptying

Treatment and Disposal

ADEPT reported little disruption across EfW, MBT, Landfill. Effects of Social distancing on operational practices causing the greatest challenges for other facilities

EA restrictions on storage temporarily lifted

Approximately half of WDAs are continuing to operate their Material Recycling Facilities (MRFs) -43% are operating normally, a further 12% are experiencing minor or moderate disruption.

Two thirds of WDAs (65%) report that they have suspended the use of open windrow composting.

Panic buying – now stopped?

Changes to waste composition – increases in card?


Could we see a sharp decline in revenue?
